Notice is hereby given that on 26 May 2016, the National Power Corporation (NPC) filed a *Petition* dated 10 May 2016 seeking the Commission's approval of the availment from the universal charge for missionary electrification (UCME) for Calendar Year (CY) 2017, with prayer for the issuance of provisional authority.

On 23 January 2017, the Commission issued an Order setting the instant case for determination of compliance with the jurisdictional requirements, expository presentation, Pre-trial Conference, and presentation of evidence on various dates and venues.

On 29 May 2017, the Commission issued an Order cancelling the Expository Presentation scheduled on 08 June 2017 in Davao City and the Pre-trial Conference and Evidentiary Hearing scheduled on 29 June 2017 in Pasig City, due to security concerns.
